9. All matters relating to National Pharmaceuticals Pricing Authority including related functions of price control/ monitoring
10. All matters relating to National Institute for Pharmacy Education and Research
11. Planning, development and control of; and assistance to, all industries dealt with by the Department
12. Bengal Chemicals and Pharmaceuticals Limited
13. Hindustan Antibiotics Limited.
14. Indian Drugs and Pharmaceuticals Limited.
15. Karnataka Antibiotics and Pharmaceuticals Limited.
16. Rajasthan Drugs and Pharmaceuticals Limited.

(II) /Divisions & their duties.

The work of the Department has been organized into three Divisions viz. Pharmaceuticals Industry Division, Public Sector Undertaking Division and R&D Division comprising National Institute of Pharmaceuticals Education & Research, (NIPER) and Research & Development. The National Pharmaceuticals Pricing Authority (NPPA) an attached office of this Department, is entrusted with fixation and revision of prices of Pharmaceuticals products under DPCO 1995. Beside this, there are seven central public sector undertakings (CPSUs) viz Indian Drugs and Pharmaceuticals Limited (IDPL) Hindustan Antibiotics Limited (HAL), Bengal Immunity Limited (BIL) and Smith Stanistreet Pharmaceuticals Limited (SSPL) Karnataka Antibiotics and Pharmaceuticals Limited (KAPL) Rajasthan Drugs and Pharmaceuticals Limited (RDPL).

National Institutes of Pharmaceuticals Education & research (NIPERs) are autonomous institutions under this department.
